Cuestiones administrativas y financieras

ADMISIÓN DE OBSERVADORES

1. El presente documento ha sido preparado por la Secretaría.

2. En el párrafo 7 del Artículo XI de la Convención se declara que:

cualquier organismo o entidad técnicamente calificado en la protección preservación o administración de fauna y flora y que esté comprendido en cualquiera de las categorías mencionadas a continuación, podrá comunicar a la Secretaría su deseo de estar representado por un observador en las reuniones de la Conferencia y será admitido salvo que objeten por lo menos un tercio de las Partes presentes:

- a) *organismos o entidades internacionales, tanto gubernamentales como no gubernamentales, así como organismos o entidades gubernamentales nacionales; y*
- b) *organismos o entidades nacionales no gubernamentales que han sido autorizados para ese efecto por el Estado en que se encuentren ubicados.*

3. En el párrafo 3 del Artículo 4 del Reglamento de la Conferencia de las Partes se estipula que:

Cualquier organismo u órgano a que se hace referencia en el párrafo 2 de este artículo que desee estar representado en una reunión por observadores deben someter los nombres de esos observadores, pagar la tasa de participación estándar a la Secretaría al menos 60 días antes de la apertura de la reunión y presentar:

- a) *evidencia de la aprobación del Estado en que se encuentre en el caso de un organismo u órgano nacional no gubernamental; o*
- b) *evidencia de que tiene una personalidad jurídica y un carácter internacional, un mandato y un programa de actividades en el caso de un organismo u órgano internacional no gubernamental.*

4. Estas disposiciones se aplican a todos los organismos y entidades distintos de la Organización de las Naciones Unidas y de sus organismos especializados y de la Organización Internacional de Energía Atómica (que no están sujetos al procedimiento de admisión enunciado del párrafo 7 del Artículo XI de la Convención, en virtud de lo previsto en el párrafo 6 del mismo artículo y en el párrafo 1 del Artículo 4 del Reglamento).

5. En Anexo al presente documento figuran todos los organismos y entidades que comunicaron a la Secretaría antes del 24 de marzo de 2019 su deseo de estar representados en la presente reunión por observadores.

6. La lista que figura en el Anexo se somete a la Conferencia de las Partes a fin de que considere la admisión de los observadores de conformidad con el párrafo 7 del Artículo XI de la Convención.
